THIS AGREEMENT entered between Art Partners, LLC (“Binders”) and _____ (“Teacher”).

1. In consideration for the covenants and conditions set forth herein, the parties hereto agree as follows:
2. Binders shall pay teacher in the amount of _____ for the services rendered as agreed to in Teacher Workshop Requirement Document: (attached)
3. Binders will make every effort for teacher to have unimpeded access to classroom as agreed to in Teacher Workshop Requirement Document (attached). In the event Teacher is denied access to classrooms, other than catastrophic causes, Binders will pay teacher full amount of agreed fee.
4. Cancellation/Policy. Binders will make every effort to fill minimum student requirement for teacher class. In the event the class does not meet minimum student requirement, Binders will cancel class _____ (days) before initial class date. Binders will not be liable for any additional fees or charges and agreed payment for class is void.
5. Teacher Absence: In the event that the teacher does not show for agreed workshop, Binders reserves the right to invoice teacher for charge back fees associated with additional student credits or costs that Binders might occur in order to satisfy students in whole.

This contract shall be governed by, construed and enforced according to the laws of Georgia. The parties further waive personal jurisdiction and submit themselves to the jurisdiction and venue of Fulton County, Georgia in all disputes regarding this contract. If this Agreement must be enforced through an attorney at law, the losing party shall be liable for reasonable attorneys fees and expenses of litigation.

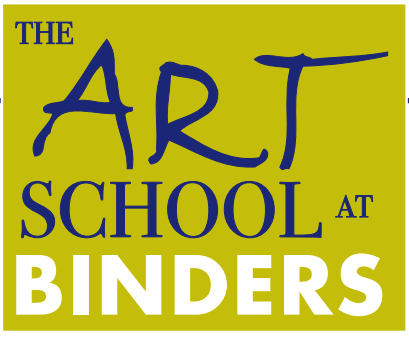
